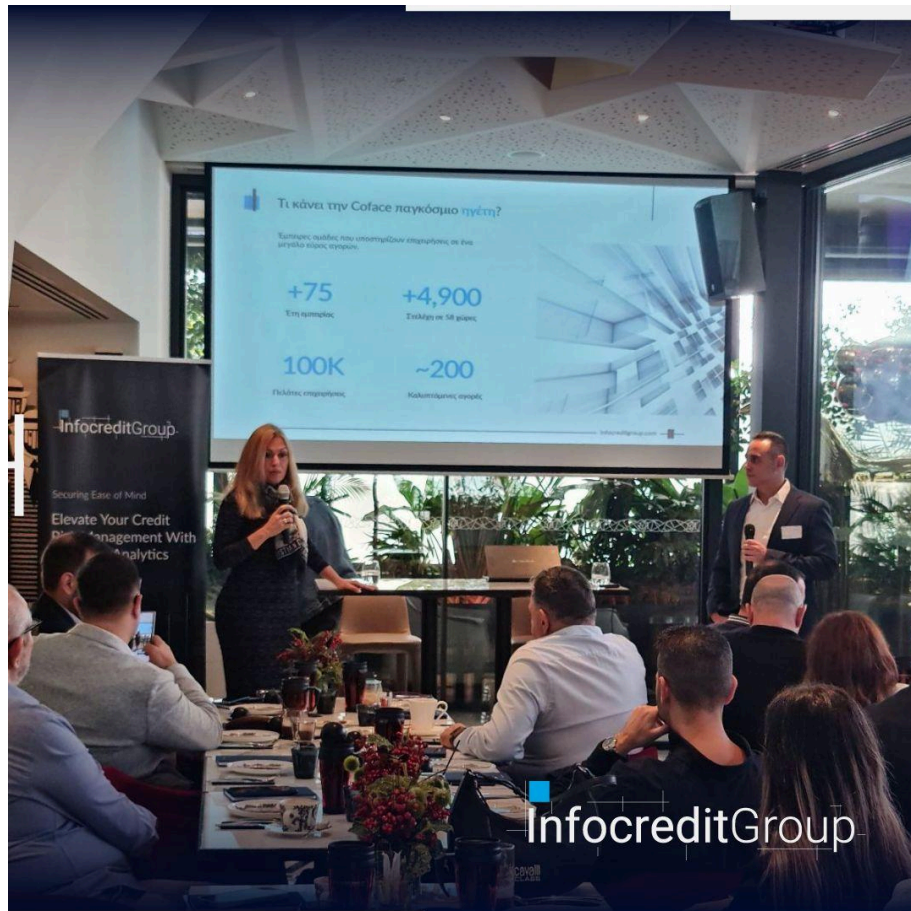


Infocredit Group Hosts Successful Business Breakfast Event with Coface, Greece
